Review of projects for 2003/04

Review of proposals for 2005/06

1. RAS/8/082 & RAS/7/013- Improved information of urban air quality management in the RCA region

Air pollution is identified as one of the major environmental problems in Australasia. This programme tackles local and transboundary air pollution issues.

- The programme focuses on the regional aspect (transboundary air pollution) after having achieved an awareness of air pollution in the RCA region.
- > Regional interest is supported by regional action plan by ESCAP member states; also Asian countries.
- ➤ 16 member states; The air pollution programme enjoys strong government commitment as indicated by the evidence provided.

SUCCESS STORIES (three examples)

- o With the help of this programme, the legislation was changed in Bangladesh and the Philippines resulting in a reduction of lead in petrol.
- o Well established national programmes, like to one running in Australia, are enjoying strong government and commercial support. ANSTO in Australia has just finished a two year Australian Coal Assoc. Res. Project (ACARP) for A\$220,000.
- o Upcoming participants, such as Thailand and Sri Lanka, are having now strong links to overseas laboratories (RRUs) that enable them to measure filters on time and elements they could not access, such as Na, S, Si, Pb etc. There national reputation is increasing resulting in leadership positions in their countries.

2. RAS/8/097 – Isotope techniques for groundwater contamination studies in the urbanized and industrial areas

Similar to air pollution, groundwater pollution is one of the major issues in Australasia in environment. Establishing access to clean water is a primary objective of all programmes running in groundwater pollution. This programme was refocussed in 2002.

- > This new programme is based on the previous success story of identifying As in GW in Bangladesh.
- ➤ It focuses on the development of methodologies on GW pollution with the aim to have an impact on management decisions.
- > 12 member states; Regional interest is supported by regional action plan by ESCAP member states.

3. RAS/8/076 & RAS/7/011 - Enhancing the marine coastal environment

Enhancing the marine coastal environment is another important issue in Australasia. Establishing nuclear based techniques that are able to assist with this complex task is a key objective of this programme. Special attention is now drawn to harmful algal bloom, pollutants and regional databases.

- > The HAB sub-project of the programme enjoys a significant government commitment as indicated by the evidence provided.
- > Regional interest is supported by regional action plan by ESCAP member states; also Asian countries.

SUCCESS STORIES – End-users are attracted to the HAB programme and provide funding for Indonesia and Vietnam.

4. RAS/8/092 - Investigating environment and water resources in geothermal areas

Scheduled to finish in 2004. Focussed on promoting the development of nuclear techniques to investigate the impact of geothermal areas on water resources.

The programme enjoys significant government commitment as indicated by the evidence provided.

SUCCESS STORIES – Radiotracers used successfully for the first time in sandstorm reservoir (China).

Results supported decision making regarding injection management (PHI).

5. RAS/8/093 - Use of isotopes in dam safety and dam sustainability

Scheduled to finish in 2003. Focussed on the use of environmentally safe isotope techniques in the operation and management of dams and reservoirs.

The programme lacks of government commitment from many countries. Only four countries submitted governmental commitment.

SUCCESS STORIES – None reported to date.

6. RAS/8/095 – Improving regional capacity for assessment, planning and responds to environmental emergencies

This new programme s of high interest for the region and is focussed on the improvement of the regional capacity to respond in the management of aquatic environmental risks. It is scheduled for 2003 and 2004. The programme is funded by AUSAID.

SUCCESS STORIES – None reported to date.

Proposals for environmental sector for 2005/06 cycle - general comments

- Many proposals are not in an adequate form making their assessment very difficult.
- Many proposals do not address specific requirements, such as:
 - > UN millennium development goals (MDG) poverty, environmental sustainability
 - Johannesburg declaration on sustainable development
 (Sustainability of programme is not addressed (building partnerships on nuclear technology))
 - > Real needs for member states are not precisely spelled out
 - > Government commitments are not clearly identified.
 - Linkages to national programmes are often not outlined.
 - > Some programmes are research focussed not problem focussed.

- No clear linkage to industrial and health RCA programmes
- Disappointing quality of proposals (submission route has to be established)
